Water accountability Report

Still experiencing unaccounted for water.

Discussion ensued on how to keep better track of where water went. There could be leaks going undetected but once a leak was fixed calculate how much was lost.

April and May experienced higher water loss. Need to account for water loss.

With low water levels it will be easier to detect leaks.

One leak on 450 Panaroma Drive (`21,600 gallons lost)

No coliforms found for April or May

Regulatory Assessment is not being billed. Regulatory Assessment is a tax and every year in Jan TCEQ charges ½ of 1% of all water sales. 3G does not bill its customers for that but you can do that without fear of rate protest.

Last two months it has been around 20,000 +/-

20,000 x 12 x 85% (seasonal) = 204,000 x 1% divide by 2)

1020.00/265 users 3.80/year .32 cents a month per person

Not on agenda for action but advises to consider it.

Patrick only knows of two fees

- 1. Regulatory Fee
- 2. Water System fee \$250-\$500 annually comes up in June help to defray TCEQ cost

Discussions ensured about changing from Prosperity Bank general checking to Lone Star Capital Bank to save money then move the Prosperity MMA to a TexSTAR account for higher interest and money is completely liquid. Board decided to wait util president (Nancy) is back to make change.

Generator Issue

Discussion ensued about the report from Fleet Load is overbearing at start up suggested we put in time delays for start up Fleet Maintenance recommended Capital for generators EJ working on selling 4 inch pipe was discussed and finding someone local would be beneficial Discussed eliminating Frontier telephone line but need to know which lines are data lines. Research needs to be done.

Lake is getting lower and is predicted to get lower and it would be cheaper to put line in lake when water is lower. We have gotten approval from TCEQ to put line across a lake. They offered a variance we could do it under certain conditions. Cost of 8 conditions and how prohibited were discussed.

Golden Beach use to get free water (HOA) to water trees in the GOA park. Need to run the meter to have water accountability. It appears they received a bill but it was credited back. Park meters do not get charged.
